DOCUMENT: Valid National Identity Card issued to Nationals of: Austria, Belgium, Finland, France, Germany, Greece, Italy, Liechtenstein, Luxembourg, Malta, Monaco, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland.

For all other countries valid passport is required.

MINORS: Identity card for minors (Certificato di nascita per minori) issued in Italy, and valid abroad.

Only children of bearer can be included in Italian passports:

- without photo in Italian parent's passport up to the age of 10 years. Validity of said inclusion expires when child becomes 10 years old, even if parent's passport is still valid.
- with photo in Italian parent's passport up to the age of 16 years. Validity of said inclusion expires when child becomes 16 years old, even if parent's passport is still valid.

VALIDITY: Identity Card and Passport must be valid, at least, for the duration of cruise.

MULTIPLE ENTRIES VISA IS REQUIRED except for nationals of:

Andorra, Argentina, Australia, Austria, Belgium, Bolivia, Brazil, Brunei, Bulgaria, Canada, Chile, Costa Rica, Croatia, Cyprus, Czech Rep., Denmark, El Salvador, Estonia, Finland, France, Germany, Greece, Guatemala, Honduras, Hungary, Iceland, Ireland, Israel, Japan, Korea Rep.(South), Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Monaco, Netherlands, New Zealand, Nicaragua, Norway, Panama, Paraguay, Poland, Portugal, Romania, San Marino, Singapore, Slovak Rep., Slovenia, Spain, Sweden, Switzerland, U.K., Uruguay, U.S.A., Vatican City, Venezuela.

GREECE

VISA IS REQUIRED except for nationals of:

Andorra, Argentina, Australia, Austria, Belgium, Bolivia, Brazil, Brunei, Bulgaria, Canada, Chile, Costa Rica, Croatia, Cyprus, Czech Rep., Denmark, Ecuador, El Salvador, Estonia, Finland, France, Germany, Guatemala, Honduras, Hungary, Iceland, Ireland, Israel, Italy, Japan, Korea Rep.(South), Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Malaysia, Mexico, Monaco, Netherlands, New Zealand, Nicaragua, Norway, Panama, Paraguay, Poland, Portugal, Romania, San Marino, Singapore, Slovak Rep., Slovenia, Spain, Sweden, Switzerland, U.K., Uruguay, U.S.A., Vatican City, Venezuela.

Those irrespective of nationality holding an official Residence Permit issued by one of the Schengen States (Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden) no need visa for travelling in all Schengen States.

TURKEY
